# 4. FIRST AID MEASURES

**EYES:** Remove to fresh air. Wash skin contact area with soap and water. Flush eyes with water and report to physician immediately. If ingestion, any type of overexposure or symptoms of over exposure occur during or following the use

of this product, contact a poison control center, emergency room or physician immediately; have Material Safety Data Sheet information available.


